

Notice to all Public Officials:

The bearer of this card does hereby lawfully notify you that you are commercially liable for any violation of his or her rights, and that the bearer:

- 1) Reserves all religious, constitutional, civil, human, and sovereign rights.
- 2) Will not consent to any search of their person or property.
- 3) Will not answer any questions without a 'public servant questionnaire' pursuant to the Privacy Act of 1974 USC sec. 88 stat. 1896 (1974).
- 4) Will hold liable under full commercial liability for damages through civil suit any public servant who deprives them of, knowingly allows them to be deprived of, conspires to deprive them of, is "negligent through deliberate indifference to", or discriminates against these reserved unalienable rights pursuant to Title 42 (Equal Rights Under The Law) particularly 42 USC 1981, 1983, 1985, 1984, 18 USC 241 and 242.
- 5) Will exercise the spiritual tenents of their personal creed under protection of the first amendment and the Religious Freedom Restoration Act of 1993.

Public Officials who violate their oath to uphold the U.S. Constitution may be liable for civil suit, criminal charges, and/or class action suits.
